The 25th MAB ICC session

International Co-ordinating Council of the Man and the Biosphere (MAB) Programme held its 25th session in UNESCO Headquarters, Paris (France) 27-30 May 2013. For item 6 "Reports on actions undertaken by Member States / regional and thematic MAB Networks in the context of MAB", Mr Kilrim Ko from Jeju BR provided a succinct report on the activities of the World Network of Island and Coastal BRs. In this report, he summarized on the major outcomes produced by the first meeting of the Network in Menorca and the second one in Jeju, and then notified of the meeting in Estonia, then planned. Lastly, he briefed on the performances of the two Secretariat offices, as follows.

The budget of the Consell Insular of Menorca for 2013, includes € 40,000 as a contribution to the UNESCO for this Network. Also, they have an allocation of € 30,000 for expenditure on research and implementation of joint coordination projects.

In September 2012, Jeju signed an agreement with UNESCO to help fund the establishment of World Island and Coastal Biosphere Reserves with a total of 500,000 USD for the five years from 2012 to 2016, and already provided 100,000 USD for the first year. This fund will be used together with UNESCO for seminars, training programs, and expert group activities, and will be used to support research projects related to climate change in the world island and coastal biosphere reserves.



Korean BR Network Cooperation

The management teams of 5 biosphere reserves in Korea had a workshop, organized and sponsored by the Korean MAB national committee. It was held on 27 June in the Jeju Natural Heritage Center, the building which houses the Jeju BR team and the Jeju technical headquarters of our Network. All the participants had a good time on field trips the next day after a heated discussion on the issues of common interest.

The major discussion subjects of the workshop were;

- 1) Plan to comply with the decisions made in the 25th session of MAB ICC.
- 2) Pending management issues of Korean BRs.
- 3) Institutionalization of the Korean Network of BRs

First of all, the decisions made in the 25th session of MAB ICC was introduced by the Korean UNESCO committee. Exit strategy for the BRs which fail to satisfy the statutory framework of criteria as a BR, the hottest discussion topic in the 25th session, was elaborately explained. Then presentations were made by each BR. Unfortunately, the Mt. Sorak BR turned out a target of worried discussion. Let me briefly describe this BR for the readers.



Mt. Sorak is actually a cluster of mountains very popular among Koreans for the beauty created by the harmony of rocky peaks, clean valley streams and lush vegetation, both evergreen and deciduous

including abundance of maple trees. This place has been well preserved due to its remoteness in old days and then by being a national park.

It happily walked into the World Network of BRs in 1992, as a national park. Almost all the surface of this BR turned into the core area



or buffer zone, with little left for the transition area. There was no problem for it to become a model case of a BR because conservation was the only focus at that time. But time has changed unfavorable to this BR by the Seville Strategy which seeks for a good balance between conservation and (sustainable) development.

This year, at its 30th anniversary as a BR, it received a recommendation from the MAB ICC to sufficiently extend its transition area. This recommendation is just an euphemism of a command because failure to comply with it in due time may kick it out of the WNB. A model case became a rotten apple. To make things worse, this BR is surrounded by many municipalities including a moderate-size city. The management team of this BR are employed as administrators of the national park. They do not have the authority or advantage to convince neighboring municipalities.

Earnest and extended discussion could not lead us to a satisfactory conclusion. But many words of ideas and encouragements were given to them. The result of their endeavor to stay as a BR remains to be seen.
